2013 Summer Financial Aid Application

**Due: March 15th, 2013**

Students enrolling in Summer courses offered at Chatham may be eligible to receive certain types of financial assistance. To be eligible for aid consideration, students must be accepted into a Chatham degree program for Summer 2012. The primary source of financial assistance for Summer study is Federal Stafford Loans, Federal Graduate PLUS Loans, and Private Alternative Loans. In very limited situations, undergraduate students may qualify for some state or federal grants.

To apply for financial aid for the 2013 Summer term at Chatham University, interested students must complete the 2011-2012 Free Application for Federal Student Aid (FAFSA) online at [www.fafsa.ed.gov](http://www.fafsa.ed.gov) prior to submitting this application. Current financial aid recipients should already have filed a 2011-2012 FAFSA. Students are encouraged to complete the summer aid application process as early as possible, but no later than the due date of **March 15, 2013**, because determination of aid eligibility may take 2-3 weeks. On time completion of financial aid forms will allow us to provide you with confirmation of your Summer aid eligibility in a timely manner. Due to the extremely short length of the Summer term, students not meeting the application deadline may jeopardize their ability to access summer aid. Please note that you must be fully registered prior to submitting this application. You are also required to attach a copy of your Summer 2013 academic schedule when you submit the Summer Financial Aid Application to the Financial Aid Office.

You will be notified of your aid eligibility via e-mail. An e-mail will be sent to your Chatham e-mail address when your award letter is available.
